Instructions to Applicants

1. Application can be submitted in Kannada or in English. Applicant's Name should be written clearly in Kannada and English in Kannada Application format. In English, Name and Address should be in CAPITAL LETTERS
2. Applicant should complete 35 years of age on 15/5/2017 (should submit relevant document)
3. Applicant's residential full address, mobile and land line phone numbers and E-mail address should be provided.
4. Filled application should be sent to Member Secretary, Karnataka State Integrated Child Protection Society (ICPS), C/o Office of the Director, Department of Women and Child Development, 1st floor, MS Building, Dr.B.R Ambedkar vedhi, Bengaluru-560001 either by registered post or personally before 15th May 2017.
5. Applicants should bear the travel and related expenses, if called for the interview.
6. Decision of Government is final in selection of candidate.
7. The tenure of each selected Child Welfare Committee and Juvenile Justice Board is 3 years.

Special Instructions to applicants

Persons to whom the following are applicable are not eligible to apply.

1. Has previous records of criminal activities.
2. Has ever indulged in child abuse, employment of child labour, child trafficking or any other violation of child and human rights or immoral Act,
3. Working in a post which does not allow him/her to give time and attention to the activities of Committee /Board
4. Fails to fulfill the education and experience specified in the Juvenile Justice Act, and Rules.
5. If he/she is a Member of Executive/Administrative committee of any Child Care Institution (CCI).
6. Actively involved in politics or have any office in political party
7. If declared as Pouper
