Section 1: Vision, Mission, Objectives and Functions

Vision

Women in Karnataka to become economically, socially and politically empowered, contributing as equal partners. Children in the state to be provided with care and protection that is required for a safe and healthy childhood, thereby laying the foundation for holistic development. Empowerment of Differently Abled and Senior Citizens.

Mission

A. Promoting social, economic and political empowerment of women through various policies and programmes such as Dowry Prohibition Act, 1961 with amendments of 1984 & 1986, The Karnataka Marriage Act 1976, Karnataka devadasis (prohibition of dedication) Act 1982 and Protection of women from domestic violence Act, 2005, mainstreaming gender concerns, creating awareness about their rights and facilitating institutional and legislative support for enabling them to develop to their full potential. B. Ensuring development and protection of children through various policies andprogrammes such as Prohibition of child marriage Act 2006 and Juvenile justice (care & protection of children) Act. 2000 and amendment Act, 2006, spreading awareness about their rights and facilitating access to learning and supplementary nutrition for targeted groups, institutional and legislative support for enabling them to grow and develop to their full potential. C. Promoting Education, Employment and Training, Rehabilitation, Social Security and Public Awareness programmes to bring differently abled persons to the main stream of the society.

Objectives

- 1 To lay the foundation for development of children below 6 years with focus on Supplementary Nutrition, non formal pre school education and awareness and capacity building for mothers about nutritional and health needs of the child, along with providing better services to beneficiaries under ICDS.
- To empower adolescent girls (11-18 years) through health check-up, & referrals, Nutrition & health education, Family welfare, ARSH & child practices, life skill education, vocational training etc
- 3 To provide safe and secure environment for overall development of children who are in need of care and Protection and conflict with law
- 4 To create awareness on the consequences of Child Marriage and to prevent child marriage in the state
- 5 To remove the bias against girl children, to correct adverse sex ratio and eradicate social evils.
- 6 To prevent trafficking of women and children
- To enable Economic, Social and Political Empowerment of women by implementing the following acts and rules [Dowry Prohibition Act,1961 with amendments of 1984 & 1986, The Karnataka Marriage Act 1976, Karnataka devadasis (prohibition of dedication) Act 1982 and Protection of women from domestic violence Act, 2005]
- 8 Providing Relief & Rehabilitation to marginalized and vulnerable women who lack family and societal support and independent means of income and takes steps to create social change to provide conducive environment for women
- 9 Encourage economic Independence among girls and women by providing support and protection
- 10 To mainstream gender concerns in policies, programmes and schemes of Government through gender budgeting.

- Motivation and capacity building of officers of state government departments for institutionalizing gender budgeting and awareness creation on the rights of women and children with special focus on differently abled persons and senior citizens'.
- 6 Setting up shelter / short stay homes for women in distress through NGOs and state governments. Providing counseling to women in distress and getting feedback of counseling done through NGOs.
- Motivation and capacity building of officers of State Government departments for institutionalizing gender budgeting processes Development of resource materials to facilitate the same.
- 8 Coordinating with other departments for convergence of programmes relating to women and children.
- 9 Skill up gradation for employment to the asset less and marginalized women and Improving access of women to micro credit finance.
- 10 Establishment and proper functioning of special schools through NGOs with financial assistance and providing General & meritorious scholarships for students with disabilities from 1st standard to post graduation.
- 11 To encourage, support and provide financial assistance to NGOs for establishment of new special schools in all discipline for children with disabilities.
- 12 To provide comprehensive total rehabilitation services at the door step of the beneficiaries by appointing educated persons with disabilities as village rehabilitation workers and Multipurpose Rehabilitation Workers at village and Grampachayath level respectively.
